

In the environmental and energy sectors, Nick represents renewable energy developers, lenders, and investors in permitting, siting, and financing matters. He advises on environmental compliance for solar, wind, and distributed energy projects, including land use and zoning, wetlands, endangered species, and federal and state environmental statutes such as the Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA) and the National Environmental Policy Act (NEPA). In addition, Nick has also defended clients in product liability and toxic tort litigation, managing discovery, working with expert witnesses, and briefing dispositive motions. Nick's litigation background gives him a unique perspective on regulatory counseling, allowing him to identify potential disputes or high-risk practices quickly and shape compliance strategies that reduce long-term risk.
