He is also skilled in handling post-merger disputes, especially those related to earnout or deferred payment clauses, having litigated such cases in California courts as well as the Delaware Court of Chancery. Micah began his career clerking for the Honorable Stephen V. Wilson in the Central District of California from 2016-2017.
