His government background also includes time as a presidential appointee to the U.S. Department of Commerce, serving as a senior adviser to the Undersecretary of Commerce for Intellectual Property and Director of the U.S. Patent and Trademark Office.

Returning to private practice, Stephen established a significant track record representing clients in investigations, pre-investigative engagement, and complex state and federal litigation with state attorneys general, congressional committees, and state and federal regulatory agencies.

Stephen's leadership has also extended to roles as outside counsel to the Harris-Walz presidential campaign, general counsel of the Democratic Party of Virginia, special counsel to Rock the Vote, and as a nonresident fellow at a Washington, D.C., think tank.

Prior to Foley, he was a partner in the Washington, D.C., office of an international law firm.
