

Specifically, she represented broker-dealer defendants in the Rule 10b-5 litigation arising out of the Orange County bankruptcy and in the SEC's "yield burning" enforcement action and the companion civil 10b-5 cases. She has tried insider trading cases and has managed securities litigation where clients are named as defendants in multiple civil actions and are the subject of SEC and DOJ investigations. Nancy also spends significant time litigating IP licensing agreements. An experienced trial lawyer, she appears regularly in federal courts of appeal, district courts, and state courts throughout the country, as well as in arbitrations and mediations.

Nancy is a member of the firm's Litigation Department and its Commercial Litigation, and Securities Enforcement & Litigation Practices. She is also a member of the International Business Team. Nancy served on the firm's Management Committee, was the managing partner of the Milwaukee office, and chaired the firm's Strategic Planning Committee.
