

#### **Class Actions**

- Obtained decertification of a US\$1bn class for Pulte Homes (was retained after the Court certified the class).\*
- Defending several crypto currency promotion class action lawsuits.
- Represented various companies including cosmetics companies, food and beverage companies, automotive manufacturers, national homebuilders, and rental car companies in multiple consumer class actions involving the Consumer Legal Remedies Act, unfair competition, false advertising, product labeling, product liability, the Unruh Civil Rights Act, the Americans with Disabilities Act, the Telephone Consumer Protection Act (and similar state laws) and other consumer protection claims; many of these cases resulted in dismissals or orders refusing to certify a class.\*
- Achieved class action victories including dismissals on motions to dismiss and demurrers as well as
  cases where dismissals were affirmed on appeal by the U.S. Court of Appeals for the Ninth Circuit and
  the California Courts of Appeal.\*
