## Diversity Fellowship Program

We proudly introduced Foley's Diversity Scholarship Program, which provided valuable support to first-year law students through scholarships. Throughout the duration of this program, we awarded scholarships to numerous exceptional law students.

We're continuing our long-standing commitment to fostering diverse legal talent with our Diversity Fellowship Program for second-year law students. These fellowships are for students who share our values and demonstrate a commitment to promoting diversity, equity and inclusion.

Each Diversity Fellow receives a weekly salary throughout the 10-week program, plus a \$50,000 fellowship, which will be paid in two installments: \$20,000 following successful completion of our 2024 Summer Associate Program, and \$30,000 paid within 30 days of joining Foley as an associate/law graduate.\* Please note that if for any reason you do not become employed by Foley as an associate/law graduate or leave the firm within six months of your hire date, you will be required to repay the firm the second installment of the fellowship within 90 days of notice.

As you consider the opportunities that await you as a 2L, we hope you'll consider Foley and this unique opportunity.

### Eligibility

Applications will only be accepted from second-year J.D. students (Class of 2025) enrolled in an ABA-accredited law school, regardless of race, gender, age, ethnicity, sexual orientation, disability, or any other characteristic or condition protected by applicable law.

## Application Requirements

- **Application to office-specific summer program** (via on-campus interview or directly on [Foley.com/Careers](https://www.foley.com/careers)).
- **Completed online fellowship application.**
- **Unofficial or official school transcripts**, including complete grades for all concluded law school semesters (you may resubmit your complete transcript with grades for both 1L semesters at a later date, once grades for the Spring semester are released).
- **Current resume.**
- **A personal statement** describing your background, accomplishments, and/or leadership experience that would help you to promote diversity at the firm and within the wider community (response should be limited to 500 words).
