One of the refinements of his practice style was the ability to utilize his understanding of dispute resolution to creatively plan and budget for the resolution of complex disputes. He has managed the successful resolution of several complex multiparty matters, resulting in great cost savings to clients.

Several of John's trial successes include securing a jury verdict in excess of \$2.5 million for a contractor against a performance bond surety in a case of first impression in Florida. He also secured a \$1.5 million settlement payment for a local government from a contractor after securing a jury verdict against the contractor and its surety in a case where John's client offered to pay \$250,000 to the contractor before the trial. He also recovered \$1.2 million dollars for a real estate client in a trial against a defaulting seller.

John has been extensively involved in community and public affairs for many years. He has received several awards and recognition for his pro bono work with dependent children and public service. He has received the Notre Dame Alumni Award for his many years of service to Notre Dame and the Orlando community and presently serves on the board of trustees of Barry University and is past chairman of the Barry University School of Law board of advisors.
